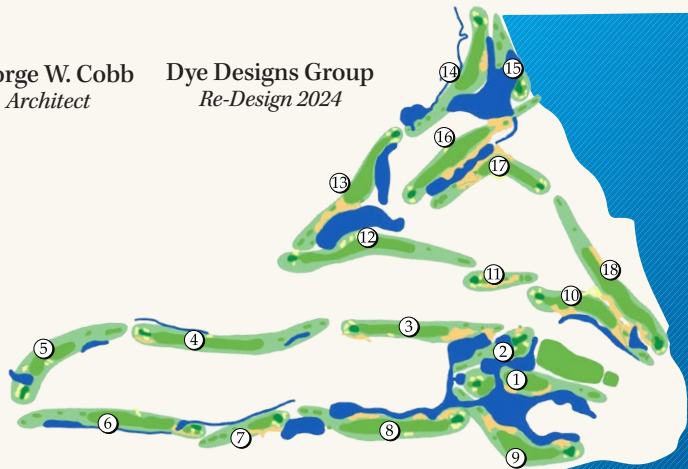

USGA RULES GOVERN ALL PLAY EXCEPT WHERE MODIFIED BY LOCAL RULES

- White and black posts in the fairway mark 150 yards to the center of the green.
- All split rail fences located on golf course property will be treated as immovable obstructions.
- Out Of Bounds is defined by white stakes, black top roads, or private properties bordering lagoons around the golf course.
- Free relief for deer hoof prints in the General Area.
- All sand areas on the golf course are not bunkers and therefore are played as a general area.
- Proper golf attire required to play course and to use driving range.
